<u>ARCHITECTURAL REVIEW COMMITTEE</u> – Three (3) positions, 3-year term. Applicants shall reside within the corporate limits of the city of Whitefish, are employed or own a business in the city of Whitefish, or own property in the city of Whitefish; or be a Montana licensed architect, or licensed design professional (i.e. architect, engineer, or landscape architect). The Committee meets twice a month April – October, and one a month November – March in the mornings.

BOARD OF APPEALS – One (1) position, term not designated. The Board of Appeals determines suitability of alternate materials and methods of construction and to provide for reasonable interpretations of the International Building Code.
